**Standard Custom Plate Initial Cost.....\$77.00**

Standard plates consisting of three numbers ranging from 100-999 followed by the letters DUX will be assigned by DMV according to the next available number. There is a \$25 annual renewal fee in addition to your regular registration fee, which is billed every two years at the time of your renewal.

**Personalized Custom Plate Initial Cost.....\$108.25**

There is a \$50 annual renewal fee in addition to your regular registration fee, which is billed every two years at the time of your renewal.

**IF YOUR REGISTRATION EXPIRES IN 60 DAYS OR LESS, YOU MUST RENEW IT BEFORE YOU CAN APPLY FOR THESE PLATES.**

This plate is also available with the International Symbol of Access (ISA) on it for any registrant with a disability who qualifies for such a plate.
