



# LONG ISLAND DUCKS 2019 PLAYER TRYOUT FORM

**Date: Saturday, April 13 (rain date - Sunday, April 14)**

Position players are to report to Bethpage Ballpark at 8:30 am for registration, while pitchers report at 10:00 am for registration. Participants must be at least 18 years of age. All participants must wear proper baseball attire to be eligible to try out. All those present should provide their career statistics and must supply their own wooden bats and baseball gloves. Cleats/spikes are only to be worn while on the field, and all players must be prepared to wear sneakers/turf shoes prior to reaching the field. All participants will be required to sign a release form before trying out for the team.

Coaches and representatives from the Ducks will be on hand to evaluate the players, including Manager Wally Backman, Hitting Coach Lew Ford and President/GM Michael Pfaff
